1	Wear appropriate personal protective equipment (PPE).				
2	Do not exceed capacity of equipment – size and/or thickness.				
3	Always keep hands clear of moveable knife and holding fingers.				
4	Material should be properly supported during cutting				
5	Hold material securely to prevent it tilting during the cut.				
6	Never reach behind Beverly Shear or allow someone to do so while operating equipment				
7	Retrieve your work piece once knife is returned to the up position and locked.				
8	Clean work area with brush – never with bare hands.				
	If an emergency occurs while conducting this task, or there is an equipment malfunction, shut the equipment off immediately and follow the lock out procedure.
