Steps to be taken to complete task safely:			
1	The employee must familiarize themselves with the save operation of equipment ar		
	electrical hazards that may occur. This includes training, lockout requirements, and sp		
	types of work practices and the required precautionary practices when using portable		
	electric equipment.		
2	All portable electric equipment will be handled in such a manner that will not damage or		
	reduce service life. Flexible cords connected to equipment may not be used for rais		
	lowering equipment and will not be used if damage to the outer insulation is present.		
3	Visual inspections are carried out and unauthorized alterations of the grounding protection		
	are not allowed to ensure the safety of employees.		
4	Prior to use, a visual inspection will be performed for external defects and for possible		
	internal damage. Attachment plugs and receptacles may not be connected or altered in a		
	manner that would prevent proper continuity of the equipment grounding conductor. In		
	addition, these devices may not be altered to allow the grounding pole of a plug to be		
	inserted into slots intended for connection to the current-carrying conductors.		
5	A visual inspection is done to identify any signs of potential sparking or burn areas.

11 When not in use and portable electric equipment must be properly stored in such a way the damage will not occur to the unit or that there is a risk of electrical shock to others in the area. A unit should be unplugged when power is not required.
