Steps to be taken to complete task safely:				
1	Wear appropriate personal protective equipment (PPE).			
2	Use proper lifting techniques to transfer hydrated lime from storage area to mixing area.			
3	Cover the bag of lime with the tarp before dumping into mixing station (mixer, wheelbarrow,			
	bucket).			
4	Only dump ½ bags at a time			
5	Allow enough time for the lime dust to settle.			
6	Stand back from the covered bag during the settling phase.			

Repeat as needed until the amount of lime needed has been reached

If an emergency occurs while conducting this task, or there is an equipment malfunction, shut the equipment off immediately and follow the lock out procedure.

Housekeeping

- Carefully dispose of any hydrated lime bags in a black garbage bag to reduce lime dust generation
- Place all materials in their proper storage areas.
- Ensure mixing area is safe, clean and tidy before you leave it.
